




Client Description	<p>The Dutch Order of Accountant-Administration Consultant (NOvAA) is an legal public body for the occupation of Accountant-Administration Consultant (AA).</p> <p>The NOvAA is a public organization. All registered Accountants-Administration Consultants, are legally bound to be members of the NOvAA. The NOvAA has more than 6,500 members.</p>

Assignment	Ensure that an up to date copy of the handbook of laws and rules (HRA) is accessible via the NOvAA intranet so that the 6,500 members can consult them. Therefore searchability and user friendliness are of highest importance.
Solution	<p>The chosen solution is made up of two parts:</p> <p>The handbook is first standardized and properly formatted and relevant meta-data is included, in order to improve searchability in the web-based surroundings.</p> <p>Then the information was connected. The connection ensures that the viewing of the data is done in an easily searchable structure before applying the appropriate rights and design markup.</p>
Approach	<p>After the preliminary investigation it appeared the data as present in "Scienta" was not yet sufficient for sufficient data synchronisation. The missing data was mapped and entered into "Scienta"</p> <p>In an expanded technical plan the coupling was written with specific attention for rights and security.</p> <p>Drecomm developed and tested the solution on a separate test server and after acceptance by the client this was moved to the live server.</p> <p>The maintenance and support plan has been expanded to guarantee continuity with the module "Scienta".</p>
Internet Intelligence factor	Originally NOvAA saw the coupling with "Scienta" not feasible, however due to technical understanding and skills, as well as good project management this was shown to not be the case.
